Violation #21. Hot holding temperatures

Increase the temperature for the hot food. At time facility was serving food outside of the cafeteria for the emergency program.

Containers for hot food must to keep in 135 F or higher. They corrected at time of inspection. Is recommended just take outside no more than 10 containers and shall be rotate every 30 min into the warmers inside the kitchen.

CODE REFERENCE: 64E-11.003(2). PHF/TCS foods, which are held hot and not subject to an approved HACCP plan, must be maintained at 135°F.
